INTRODUCTION

The following is the privacy policy (the “Privacy Policy”) of Canada Goose Inc. and Canada Goose International AG (together “Canada Goose”, “we”, “us” or “our”) who act as joint controllers of the personal data we collect about you. You may access to the essence of the joint controllership arrangement between Canada Goose Inc. and Canada Goose International AG using the contact details provided at the end of this Privacy Policy. Canada Goose recognizes the importance of your right to privacy and we are committed to safeguarding your personal data. This privacy policy sets out the way we use your personal data: what we collect, how we collect it, how we use it, why we use it, who we share it with and the rights to which you may be entitled.

CATEGORIES OF PERSONAL DATA WE COLLECT

We collect certain types of personal data from or about you throughout our interaction with you. This personal data consists of things like your name, address, contact details and online identifiers. We use this personal data for the activities we have listed in the table below, including in order for us to provide our products, for marketing, reporting purposes and investigation of complaints.

LEGAL REQUIREMENTS

In addition to the above, your personal data will be processed if it is necessary on reasonable request by a law enforcement or regulatory authority, body or agency or in the defence of a legal claim. We will not delete personal data if relevant to an investigation or dispute. It will continue to be stored until those issues are fully resolved.

AUTOMATED DECISION MAKING

We will make automated decisions on certain matters: we do this to decide whether we can provide our products to you based on fraud detection and creditworthiness checks. This will be informed by verification of your personal data (including by third parties). Depending on the outcome of these checks, a decision will be reached automatically as to whether we are able to provide products to you.

FAILURE TO PROVIDE PERSONAL DATA

Where we need to collect your personal data under the terms of a contract we have with you and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you (for example to provide our products to you).

HOW LONG WE WILL KEEP YOUR PERSONAL DATA

We will keep your personal data for as long as the relationship with you as an account holder, client (including in connection with warranty claims), user of our website and/or participant contests, sweepstakes and other promotions or features of a similar nature is maintained; while you wish to receive our marketing communications and information about our activities; as well as for as long as necessary to respond to enquiries complaints, claims and other communications you send us and to monitor information transmitted or received to prevent violations of our website terms of use or inappropriate content; and while they are necessary to fulfil a request by a law enforcement or regulatory authority, body or agency; or in the defence of a legal claim. Where you have granted your consent, data will be kept until you withdraw it and while necessary for the purpose you have consented. Afterwards, your personal data will remain blocked for the necessary period of time for the protection against potential legal or contractual actions and during the relevant statute of limitations.

With regard to video surveillance, data will be deleted after one month.

Where your personal data are processed for recruitment purposes:

- If you are offered a position at Canada Goose, your personal data will be stored in your employee file while the employment contract with you is in force. You will be provided with additional information in this regard as an employee of Canada Goose.
- If you are not offered a position, and you have not consented for us to keep it longer for future job posts, data will remain blocked for the necessary period of time for the protection against potential legal or contractual actions and during the relevant statute of limitations.

DISCLOSURE OF YOUR PERSONAL DATA

There are certain circumstances where we transfer your personal data to affiliates, contractors and to other third parties.

- We may share personal data about you with other members of our [group of companies](#) so that we can provide the best service across our group. They are bound to keep and use your personal data in accordance with this Privacy Policy;
- We also share your personal data with certain contractors, service providers or advisors that help with our business operations (for example, order fulfilment, cloud services, fraud prevention, customer services, payment processing and marketing) and they process your personal data for us. They are always required to meet our standards on processing personal data and security. The personal data we provide them with, including your personal data, will only be provided in connection with the performance of their function;
- If we're discussing selling or transferring part or all of our business the personal data may be transferred to prospective purchasers under suitable terms as to confidentiality – or if sold, to buyers who can continue to provide products to you;
- We may also share your personal data where you have given us consent to do so or when we are otherwise required or permitted by law, for example by the Police or in defence of a legal claim.

INTERNATIONAL TRANSFERS OF DATA

Some of the parties that collect your personal data and third parties (e.g. suppliers, service providers and affiliates) to which we may disclose your personal data may be located in countries outside the European Economic Area (“EEA”) and the United Kingdom. As a result, your personal data may be transferred to, stored and/or processed in such other countries, including on servers located in such other countries. This includes countries that offer a

lower level of protection for your personal data than countries in the EEA and the United Kingdom, including the United States.

Unless you have expressly consented to the transfer of personal data, the transfer is necessary for the performance of a contract with you or concluded in your interests or the transfer is otherwise permitted by applicable data protection laws we will only transfer your personal data to a country that is deemed to have an adequate level of protection under the applicable data protection law or otherwise where we have put in place adequate safeguards to protect the personal data. In particular where we send your personal data outside of the EEA and the United Kingdom, we shall only do so where the recipient of the personal data is subject to:

- binding corporate rules;
- standard data protection clauses approved under applicable law;
- an approved code of conduct; or
- an approved certification mechanism.

The transfer of your personal data to Canada Goose International AG, a Swiss entity, is permitted on the basis of the European Commission's decision that Switzerland provides an adequate level of protection for personal data. The transfer of your personal data to Canada Goose Inc., a Canadian entity, and our suppliers based in Canada, is permitted on the basis of the European Commission's decision that Canada provides an adequate level of protection for personal data. We also store personal data on cloud servers located in the United States. The transfer of this personal data is governed by a contract including standard contractual clauses approved by the European Commission, or by another approved safeguard.

COOKIES, WEB BEACONS, TAGS AND OTHER SIMILAR TECHNOLOGIES

Our website (www.canadagoose.com) uses automatic data collection technology and services such as “cookies”, “web beacons”, “tags” and other similar technologies. A cookie is a small data file that is placed on the hard drive of your computer so that your computer will “remember” information when you visit a website. Web beacons and tags are small strings of code that are used in conjunction with a cookie and that allow us to record activity on our website. A web beacon allows us to capture certain additional types of information about a visitor’s actions on a website, such as a visitor’s cookie number, the time, date, duration and number of page views, a description of the page where the web beacon is placed, and details about any items that were purchased.

When you use our website, these technologies may record and collect personal data, such as information that identifies your computer, tracks your use of our website and collects certain information about you and your surfing habits. This information may include information that identifies your device, IP address, browser type and language preferences, and information about referring and exit pages and URLs, keywords, date and time, what sections of a website you visit, and other similar information concerning your use. This information is used for the purposes mentioned above and to help us serve you better by improving our website design, as well as our products, services, and promotions. We also use the technologies mentioned above to improve functionality of our website and user experience.

Our website uses the web analytics service Google Analytics that is provided by Google, Inc., 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA ("Google"). Google Analytics uses "cookies". The information generated by the cookie on your use of the platform will be transmitted to and stored by Google on servers in the United States. We have activated the so called "IP-anonymization" which means that your IP address will be truncated within the area of the European Union or the EEA and the United Kingdom before being transferred to the United States. Only in exceptional cases the entire (ie. non-truncated) IP address will be transferred to a Google server in the US and truncated there. SECURITY

We maintain technical, physical and administrative security safeguards to protect personal data against loss and any form of unlawful processing (such as theft and unauthorized access). Any personal data you provide to us is exchanged on a secure server. Furthermore, our website is secured by SSL-encryption to protect data from unauthorized access when transferring them over the Internet.

YOUR RIGHTS

You have certain rights in relation to your personal data including a right to access and to correct the personal data we hold on you. Some of these rights will only apply in certain circumstances however, such as the right to be forgotten or the right to request that we move your personal data to another company. For example, the right to be forgotten will not be available if there are outstanding contracts between us, if we are required by law to keep the personal data or if the personal data is relevant to a legal dispute. - **Right to withdraw consent:** You can remove consent, where you have provided it, at any time, as well as update any of your opt-in marketing preferences by contacting us.

- **Right to rectification:** You are entitled to have any incomplete and inaccurate personal data held by us rectified. If you have an account with our online store, you can log in and update your account personal data, including contact, billing and shipping personal data.
- **Right to erasure ('to be forgotten'):** In certain circumstances you are entitled to have personal data erased. If you request that we erase your personal data we shall advise you if we consider that there are on-going grounds permitting us to continue processing your personal data.
- **Right to restrict processing:** You can ask us to restrict the processing of personal data we hold about you in certain circumstances. We will advise you if we do not agree with your request to restrict processing and our reasons.
- **Right to data portability:** In certain circumstances you can ask us to help you move your personal data to other companies.
- **Right to object:** You are entitled to object to our collection, use of and otherwise processing of your personal data where the basis for the processing is our legitimate interests or the processing is in the public interest. You may object to processing for direct marketing purposes at any time.

- **Right to complain:** In the event that you have any questions, concerns or complaints regarding this Privacy Policy or the manner in which we collect, use and otherwise process your personal data we shall always seek to address the same promptly and to your satisfaction. However if you consider that we have not done so you are entitled to lodge a complaint with the relevant supervisory authority in your jurisdiction.

UNSOLICITED COMMUNICATIONS

Canada Goose complies with applicable laws regarding unsolicited marketing messages (e.g. 'spam') and will not send you such messages in contravention of such laws. Our online store allows you to sign up and expressly consent to receiving electronic communications. We will ensure that each email includes an opt-out feature and instructions on how to un-subscribe if you no longer wish to receive future e-mails from us. You may also contact us at cesupport@canadagoose.com to stop receiving them or can unsubscribe using the link included in the e-mail. If you have not expressly opted-in to receiving electronic marketing communications, we will only communicate with you if we are otherwise entitled to do so by applicable law.

CHILDREN'S PRIVACY

Our website is not intended for use by children under the age of 13 (except when local law provides for a different age limit) , and we do not knowingly collect personal data from such children through our website. If you are under 13 (or the age provided by local law) , please do not give us any personal data. If we learn that we have collected the personal data of such a child we will take steps to delete the personal data as soon as possible.
